5. Any and/or all wetland areas located on the property to be acquired/developed have been identified and will be protected in accordance with applicable state/federal laws and regulations.
6. The property to be acquired/developed has not been used for storage/disposal of toxic chemicals/waste and is not affected by such a site.
7. The Applicant is not under suspension or debarment by the Commonwealth or any governmental entity, instrumentality, or authority.
8. The Applicant is not delinquent in the payment of any Commonwealth obligation, including taxes.
9. The proposed project is not in violation of the Governor's E.O. 2003-2 for "Preservation of Prime Agricultural Lands."
10. If the Applicant is an "Authorized Organization", as defined in the Grant Program Requirements & Guidelines, the Applicant shall not directly or indirectly, preclude access to or use of any forested land for the practice of sustainable forestry and commercial production of timber or other forest products.
11. The Applicant has assessed the administrative, cash, and/or non-cash needs that will be required to provide the local match for the grant applied for and affirms that the match is available and the Applicant has the capacity to proceed with the project.
