## Work Session

Also present were Mayor Boyd Hoats Jr., Engineer Christopher Borton, and Borough Secretary/Coordinator Denise Syms. There were eight (8) visitors.

President Chacke called the work session to order at 7:30 p.m.

Bill Letwinski, Rob Mericle, and Brian McManus from Mericle Real Estate addressed Council regarding the Mericle property on

and the change of parking that is proposed in the

project. They feel the change from parallel parking to diagonal parking will impede their truck egress and ingress. A long discussion ensued.

Dave Yefko, Borton-Lawson Engineering, discussed the Commerce Park project time-line. The project will go out for bid in March.

President Chacke gave an update regarding the discussions with Kingston pertaining to the police. Kingston Police are meeting with the FOP regarding questions that were raised.
