Motion by Mr. Kamus to appoint Andy Tuzinski as Health Officer. Second by Mrs. Craig. All council was in favor of this motion. Motion passed.

Motion by Mrs. Craig to appoint Marla Anthony as Borough Secretary/Treasurer. Second by Ms. Troy. All council was in favor of this motion. Motion passed.
